

SUBJECT: MSC NOTICE --- New Regulation for Advanced Cargo Information in Egypt 3rd UPDATE

DATE: 23 June, 2021

Dear Customers,

Please take note that the new Import regulation in EGYPT (Advanced Cargo Information ACI) will start 1st July 2021 – **Departure date from POL** .

埃及新规将自开船日 7 月 1 日起正式实施， 我司重申以下要求并请各代理务必在 SI 阶段提供正确信息。

As a reminder, pls kindly note below updates and go into effect.

- Shipper has to advise ACID number on booking level(SO) as to be mentioned on all shipping documents thereafter. (for ex: 4988470982020120017)
 - 1) Must match with that on SI. If any amendment on ACID number pls check with booking team and local DOC team case by case. **Not** allow to revise the number on SI directly.
 - 2) In case of combine request, pls combine into the minimum booking No. to avoid any discrepancy on ACID between SO & SI.
发货人应在订舱阶段提供 ACID 号码并后续将应用于所有货运单据。

1) 该号码 SO 与 SI 阶段必须保持一致， 不允许在 SI 阶段直接更改， 如需更改请与订舱部及当地文件部单票确认， 否则我司将以 SO 阶段的 ACID 为准。

2) 如涉及并单， 请务必以最小关单号为主票以避免订舱号与 ACID 不匹配， 我司将以发送 SI 的订舱号在 SO 阶段提供的 ACID 为准。

- All shipping documents should mention the ACID number for cargo to Egypt & Exporter Registration Number & identification numbers (TAX ID) of cnee & notify on the BL. (for ex: US-02-1208614364)

- **10-digit HS code** required to be manifested

1.Full 10-digit HS code. Required to be shown on cargo description & manifest. If multiple HS Code involved under cargo, pls display all complete codes on BL.
