Since AMS(ADVANCED MANIFEST SECURITY) filing has to be submitted 24 hour prior loading, pls follow below main points for correct declaration to Customs.

AMS FILING BY NVOCC

AMS filing 由无船承运人自发

1. NVOCC shipments will be manifested AMS certified with SCAC code.
需有 AMS 资质的无船承运人
2. FFWD shipper/consignee can be manifested.
收发货人可显示代理信息

AMS FILING BY MSC

AMS filing 由 MSC 代发

Real shipper/consignee must be manifested as below scenarios.

必须提供真实收发货人信息, 如下两种情况:

- A. Direct customers provide real shipper=BL shipper, real consignee=BL consignee, notify=BL notify
出直单, 提单舱单一致, 并且为真实的收发货人, 通知人提单舱单保持一致
- B. Non AMS certified NVOCC real shipper=Manifest shipper, FFWD shipper= BL shipper; real consignee=Manifest consignee, FFWD consignee=BL consignee, notify=BL notify
出阴阳单, NVOCC 没有发送 AMS 资质, 真实收发货人作进舱单, 提单显示代理信息; 通知人提单舱单保持一致
