

SUBJECT: MSC NOTICE --- DOCUMENTATION REQUIREMENTS FOR Saudi Arabia update

Dear Customers, 尊敬的客户,

Referred to the import requirement for POD Saudi Arabia, please read below carefully and comply with on your S/I.

请查阅如下目的港沙特要求,请仔细阅读并严格遵守。

- 1. Any amendment after the vessel's departure might be subject to customs penalties. 请注意进口至沙特阿拉伯货物船开后任何更改海关可能征收高额罚金。
- 2. Local consignee email address & mobile number is mandatory for all import b/ls under Consignee's field. In case consignee is "To Order / To Order of bank", mobile number & email address of actual consignee is mandatory under "Notify Party". Non-compliance will result in penalties which will be on your account.

所有运往至沙特的货物,提单收货人栏必须为当地信息且显示邮箱地址及**手机号**;若为不记名提单时,提单通知人栏必须显示当地真实收货人的邮箱地址及**手机号**,如未按要求提供一切责任风险请自行承担。

For MH8 users, the email address and mobile phone number in the Consignee/Notify Party section on BL must be submitted together with the manifest.

3. This is to remind you that for importing any vehicles to Saudi Arabia, CHASIS NBR must be inserted under Customs Number/Reference and shown on cargo description.

FAILED THERE WILL BE PENALTY FROM CUSTOMS.

4. For all Damman transshipments to "Economic Zone" and "BONDED AREA or FREE ZONE", the corresponding transshipment terms must be included in the cargo description. MH8 users must provide the relevant information in the FNL Subloc field
