

CHARCOAL RELATED CARGO BOOKING PROCEDURE

Dear all valued clients,

Due to special stowage requirement, this serves to inform that we additionally request you to send the Container List to MSC VOP Team and Booking Team before cy-closing time for each CHARCOAL /CARBON shipment with immediate effect.

由于碳类货物有特殊的配载要求,从即日起,所有炭类货物需要在截港前提供装箱清单至我司船舶操作部和订舱部。敬请注意。

1. ALL charcoal shipments (no matter hazardous or non-hazardous) on MSC vessels must ALWAYS be covered with <u>a letter of indemnity</u> signed and stamped by both Shipper on B/L and booking agent. – can be downloaded from LINDO website "服务指南-出口订舱相关-特殊货物相关".

Please fulfil all necessary parts without failure, also we need shipper's signature and company stamp along with booking agents'.

2. Whenever the consignment of charcoal is exempted to the provisions of the IMDG Code because the charcoal has passed the test for self-heating substances, the following additional documentation must be provided:

已经通过自发热测试不归类于危险品的碳类货物,必须另外提供以下文件:

- <u>The self-heating certificate</u> annex test report with the results of the self-heating test. Client may go to whatever institute that has been accredited by the competent authorities such as "Shanghai Research Institute of Chemical Industry Testing Centre" to make self-heating certificate.
- **自发热物质检验证书**(客户可去任何相关权威机构做此证书,如上海化工研究院)
- <u>A detailed analyses report</u> of the product (a MSDS, must include the IMDG regulations in the section of the transportation information)
- 详细的分析报告(MSDS,必须含有在参照 IMDG 标准下的货物运输条件的信息)。
- <u>Certification for Safe Transport of Chemical Goods</u> (the Cargo manufacturer must be the same as on 'Selfheating Certification)
- **货物运输条件鉴定书**(由上海化工研究院出具,且生产商必须与自发热物质检验证书上的生产商一致)
